- This year's Australia Day Pioneer Women's Day Ceremony, with Emma Page Campbell as guest speaker, was at the Women's Peace Garden, Kensington, a beautiful place for such a ceremony.
- In August the annual My Vote My Voice event at Parliament House will take place. This public speaking student event, promoting empowerment of women by encouraging young women to investigate and speak on diversity in community workplaces, is proving to be popular with an increasing number of schools registering for their students to take part.

We look forward to seeing you at the Annual General Meeting, Thursday 6<sup>th</sup> September, 12 noon for 12.15pm start at Level 4, Ross House, 247 Flinders Lane, Melbourne. Refreshments will be available.
